# Rules & Roleplaying Sessions – 5:00 p.m. until 5:45 p.m.

Rules & Roleplaying sessions are your students' last chance to ask questions about AMUN rules and procedures before the start of the Conference. We highly encourage the attendance of all students at these sessions, even if they have had prior Model UN experience. To promote AMUN's educational goals, many AMUN rules differ from rules of debate at the United Nations.

- CCPCJ Sheraton II (Ballroom Level)
- Security Council & Historical Security Council of 1961 Riverwalk B (Lower Level)

### Opening Plenary Session – 6:00 p.m. until 6:30 p.m.

AMUN's Opening Plenary (Sheraton & Chicago Ballrooms IV–VII) session is where the conference really gets started. We expect all students to attend the opening plenary session. This is the AMUN Secretariat's venue to announce last-minute changes to AMUN Policies, Simulation Room Assignments, and Program changes. Simulations will

begin immediately at 6:45 p.m., immediately after the close of the Plenary session. It is imperative that all participants leave promptly from the rooms for the opening plenary session as hotel staff will need to move the airwalls to divide the large room into smaller rooms so that the General Assembly committees can begin at their scheduled times. *If you arrive during the opening plenary session we politely request that you do not bring luggage into the ballrooms.*

## ICJ Advocate Meeting – 8:00 p.m. until 9:00 p.m.

All ICJ advocates are expected to attend the International Court of Justice (ICJ) Advocate Meeting in the **Superior A room** on Level 2 of the Conference Hotel, one level below the hotel lobby. This meeting will cover processes, procedures and docket times for this year's ICJ simulation. This is your advocates' chance to ask questions of the AMUN staff before presenting their cases before the court. Your advocates are highly encouraged to have a backup to cover their representation in their regular simulation so their country is well advocated for.

### Late-Night Caucus Area — 10:00 p.m. until 2:00 a.m.

This area is made available to all conference participants and is in the **Riverwalk B Rooms** on the Lower Level of the Conference Hotel, two levels below the hotel lobby. AMUN highly encourages that your team socialize with each other or with other schools exclusively in this area. AMUN asks this for both the health and safety of your students and the consideration of hotel guests that aren't participating in the AMUN Conference.

#### **Quiet Reflection Room**

AMUN and the Hotel have provided a room for reflection and prayer in the Pullman room on the east side of the lobby level. This room is open during all regularly scheduled conference hours. All representatives must adhere to AMUN's rules of diplomatic courtesy within this room. The hotel has provided a sign indicating which way is east.

#### **Caucusing Spaces**

AMUN has provided several rooms where representatives and faculty can gather for discussions and debate while simulations are in formal debate. They are located in the following rooms:

- All Representatives: Simulation Caucusing Room in Sheraton I on the Ballroom Level
- Faculty Advisors: A space available exclusively for faculty advisors in Sheraton II on the Ballroom Level
- ICJ & Security Council: Caucusing Room in the Ontario and Superior A Rooms on Level 2, one level below the hotel lobby.

If you or any member of your team arrives after the Conference Simulations begin at 7:30 p.m., please head directly to the Ohio Room on Level 2 of the Conference Hotel, one level below the hotel lobby.
